## **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IT IS FULLY UNDERSTOOD BY THE UNDERSIGNED THAT THERE IS SOME INHERENT RISK ASSOCIATED WITH THESE ACTIVITIES, INCLUDING DAMAGE TO VEHICLES.

In addition, the undersigned AGREES TO INDEMNIFY AND HOLD HARMLESS the Releasees from any loss, liability damage, or cost they incur due to such participation by the undersigned, whether caused by Releasee's negligence or otherwise and AGREE TO ASSUME FULL RESPONSIBILITY AND RISK for any bodily injury, death, or property damage from Releasee's negligence or otherwise while the undersigned is participating in any event.

THIS RELEASE/WAIVER MUST BE SIGNED IN ORDER TO BE A MEMBER OF COLORADO SPRINGS CHRISTIAN 4 WHEELERS, INC. NO DRIVER MEMBERS ALLOWED UNDER THE AGE OF 18.

In signing this release, the undersigned hereby acknowledges and represents the following:

- 1) That he or she has read the foregoing Release and Waiver of Liability and Indemnity Agreement;
- 2) That he or she shall at all times, while riding in a vehicle participating in any event, wear their respective seat belts;
- 3) That the owner/driver certifies that he or she has inspected the vehicle and same is in good mechanical condition;
- 4) That the owner/driver certifies that his or her vehicle has valid Liability/Medical Insurance Coverage for all occupants;
- 5) That the owner/driver certifies that the following basic safety equipment is on board his or her vehicle during all events: driver-accessible fire extinguisher/first aid kit/tow rope & hooks/flashlight/jumper cables/FRS radio;
- 6) That the owner/driver has informed themselves about the event and trail involved in the event, either by prior participation or by investigation into the event and trail.
